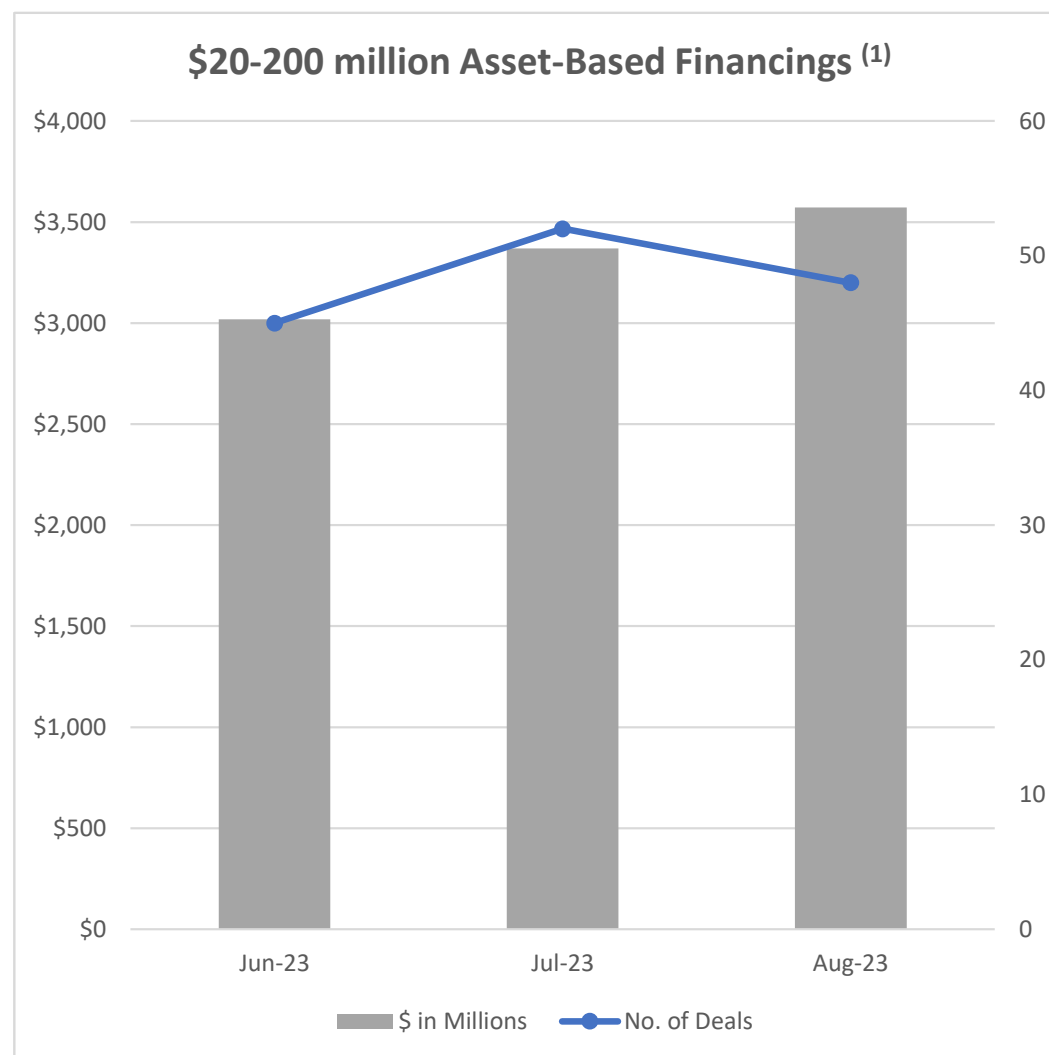


Within the \$20-\$200 million size range, there were a total of 145 asset-based financings totaling \$10 billion in last three months.
