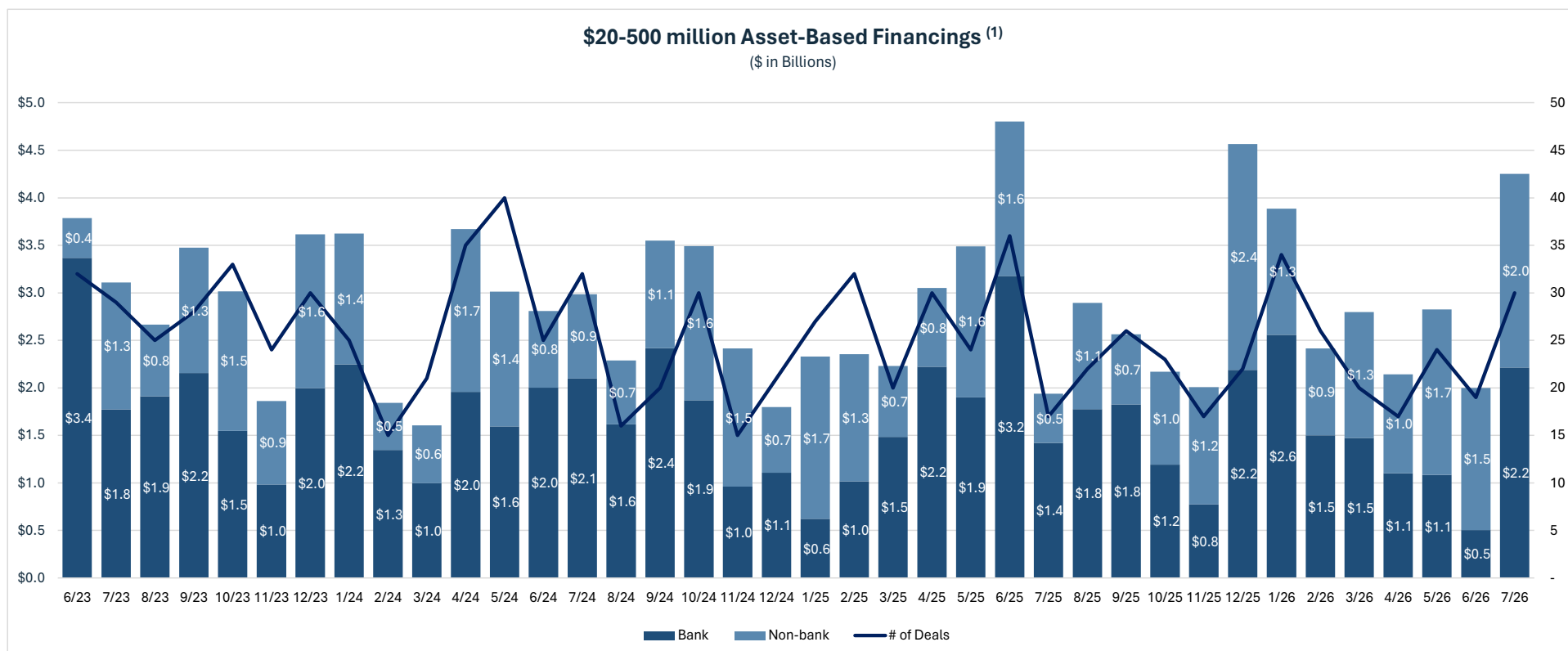


\$20 – \$500 Million Asset-Based Financing Transactions – All Announced



Within the \$20-\$500 million size range, there have been a total of **962** asset-based financings totaling **\$109.3 billion** since June 1, 2023 — **59% were funded by banks, and 41% were funded by non-banks.**

- **YTD through July 2026**, total asset-based financing volume reached **\$20.3 billion** across **170** deals — **\$10.4 billion (51%)** funded by banks and **\$9.9 billion (49%)** by non-banks.
- In comparison, **July 2025 YTD** recorded a total of **\$20.2 billion** from **186** deals, with banks funding **\$11.8 billion (59%)** and non-banks providing **\$8.3 billion (41%)** of the volume.
